Trailmaxx Trailer Sales LLC 2-year Limited Warranty

Warranty:

While your Trailer is designed to provide many years of trouble-free use, sometimes accidents happen. Please follow the below steps to get your warranty issue taken care of and put your trailer back on the road.

2 Year Structural:

Trailmaxx Trailer Sales LLC warranty covers the primary frame for 2 years. Any damage caused by overloading or improper use is not covered.

1 Year Component:

Non wearing components are covered for 1 year. Items subject to normal wear will not be replaced due to wear. This warranty does not cover wear and maintenance items.

3rd party Components:

Any third party components such as calipers, tires, axles, suspension, lights, brakes, wheels , hydraulic pumps & etc. are covered by their respective manufacturer

Trailmaxx Trailer Sales LLC, 2390 CR 1905 warrants to the original consumer purchaser for a period of two (2) years from the date of purchase by purchaser that its trailer shall be free of defects in materials and workmanship attributable to the warrantor. Excluded from this two-year warranty are electrical, wood, paint, which are warranted for one (1) year from the date of purchase by the original purchaser. Warranty is for normal use in the Continental United States.

Excluded From Warranty

Trailmaxx Trailer Sales LLC is not responsible for claims related to: (1) defacing, scratches, dents, chips, tears, on any surface not caused by the warrantor (2) routine maintenance (3) damage from unauthorized repairs, modifications, abuse, misuse or neglect (4) damage caused by improper hitch or tow hookup (5) component parts covered by separate supplier warranty. Trailmaxx Trailer Sales LLC reserves the right for final determination whether product has been misused or abused.

Warrantors Obligation

Trailmaxx Trailer Sales LLC shall elect to remedy defects in materials and workmanship caused by same at its discretion by repair, replacement or refund, if replacement or repair is not possible. All defective products shall be delivered to manufacturers address above unless prior written approval is obtained from Trailmaxx Trailer Sales LLC. Trailmaxx Trailer Sales LLC may at its discretion select another qualified location for the repair to be completed. Trailmaxx Trailer Sales LLC will not in any way be obligated to pay for repairs made without its specific approval and all costs incurred in shipping or delivery of products for warranty service shall be responsibility of the purchaser.

Purchasers Obligation

Purchaser must notify Trailmaxx Trailer Sales LLC of any defects within fifteen (15) days after it is or should have been discovered. Purchaser must complete and return warranty card within fifteen (15) days of purchase to obtain warranty service, failure to do so will void warranty.

Disclaimer of Consequential Damages

Trailmaxx Trailer Sales LLC. shall not be responsible for any consequential or incidental damages or contingent liabilities resulting from any product defects, including loss of trailer, revenue, or other commercial loss, use of rental equipment or loss of time and convenience or any other damages, general or specific, foreseen or unforeseen.

This warranty gives you specific legal rights. No action to enforce this warranty shall be commenced later than 6 months after the discovery of any defect or after the expiration of the warranty period. Any action to enforce this warranty will be subject to the laws of the state of Texas.
